Goals of the BHECN ARPA Evaluation

- 1. Monitor BHECN ARPA Award subcontract activities
- 2. Measure growth/expansion of the behavioral health workforce in NE
- 3. Reporting requirements to UNMC and the State
- 4. Establish and disseminate best practices:
 - Recruitment/retention of a diverse behavioral health workforce
 - Workforce training efforts
 - Expansion of behavioral health services to rural geographies
 - Funding for supervision of provisionally licensed providers





Timeline and Frequency of ARPA Evaluation

- ARPA Baseline Evaluation
 - Spring 2023
 - Many of the questions you answer here were included in your applications
- Annual follow-up surveys
 - January-February 2024, 2025, 2026
 - Iterations of the baseline survey, while asking you to expand on previous year's data

- Project identifier questions
 - Application number
 - Category
- Organizational questions
 - Organizational setting
 - Services provided
 - BH providers employed
- Client-specific questions





Training Opportunities Evaluation Themes

- Type of training program offered
- Providers who participate in program
- Training format/modality
- Clinical training practice settings
- Enrollment information





Telebehavioral Health Evaluation Themes

- Barriers to provision of telebehavioral health services
- Existing telebehavioral health infrastructure
- Promotion of telebehavioral health services
- Providers utilizing telebehavioral health
- Number of visits conducted via telebehavioral health
- Services provided via telebehavioral health
- Practice settings where telebehavioral health is utilized
- Client feedback





COVID-19 Evaluation Themes

- Existing educational, recruitment/retention, or research programs
- Behavioral health providers participating in programs
- Training/education types, modalities
- Recruitment/retention types
- Retention rates





Funding for Supervision Evaluation Themes

- Supervision offered
- Number/type of supervisor
- Number/type of provisionally licensed providers
- Barriers to supervision
- Clinical experiences
