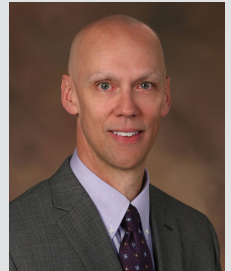
### Target Audience:
