Learn from Substance Use Disorder Experts!

What: ECHO (Extension for Community Healthcare Outcomes) is an opportunity for providers across the state to get specialist knowledge, clinical advice, and recommendations from substance use and pain management specialists in a virtual learning network.

More about ECHO: ECHO uses videoconferencing technology to connect addiction and pain management specialists with providers to discuss de-identified cases related to substance use disorders. Each ECHO call consists of a brief didactic presentation followed by a clinical case discussion from a provider and recommendations from the team for treatment.

Clinical Goals/Objectives:

• Identify the evidence-based medications available to treat patients with disorders related to the use of opioids, alcohol, and nicotine.

• Discuss which patients are appropriate for medication management for the treatment of substance use disorders including the cross-section of pain and addiction on a biological and behavioral level.

• Describe how pairing psychotherapeutic and/or psychosocial interventions with medications can impact patient outcomes experiencing pain and substance use disorders.

• Utilize effective communication strategies to facilitate discussions and interactions to enhance team function as derived from ECHO Project case scenarios.

How it works:

- Register for each call.
- Join an online video conference from your office.
- Share and discuss clinical cases related to pain management and substance use disorders.
- Learn from experts in pain management and substance use disorders.

Who should participate: Our target audience

continues to be all health care providers (physicians, physician assistants, nurse practitioners, registered nurses, psychologists, licensed mental health therapists, social workers, and licensed alcohol and drug counselors) in the state who treat patients that have pain and/or substance use disorders, involving opioids primarily.

typically the 2nd and 4th Tuesdays of the month via Zoom.
